It is hereby ordered, adjudged and decreed as follows:

(1) An award of compensatory damages for pain and suffering is proper and awarded to Susana Quiros de Rapaport in the sum of \$10 million.

(2) An award of compensatory damages for pain and suffering is proper and awarded to Maria Teresa Pinero de Georgiadis in the sum of \$10 million.

(3) An award of compensatory damages for pain and suffering is proper and awarded to Maria Elena Perez de Antonanzas in the sum of \$5 million and to Norma Antonanzas de Barroso in the sum of \$5 million.


(4) An award of punitive damages is proper and awarded to Susana Quiros de Rapaport in the sum of \$10 million.

(5) An award of punitive damages is proper and awarded to Maria Teresa Pinero de Georgiadis in the sum of \$10 million.

(6) An award of punitive damages is proper and awarded to Maria Elena Perez de Antonanzas in the sum of \$5 million and to Norma Antonanzas de Barroso in the sum of \$5 million.

(7) Costs in the amount of \$ 4,852.00 are also proper and are hereby awarded.
