**PLAINTIFF-APPELLEE'S MOTION TO STAY  
PROCEEDINGS PENDING RESOLUTION OF ITS MOTION TO DISMISS**

Pursuant to Fed. R. App. P. 27 and Local Rule 27(b), Plaintiff-Appellee Sexual Minorities Uganda respectfully moves to stay the proceedings in this Court related to the appeal docketed as 17-1593 pending resolution of its Motion to Dismiss Defendant-Appellant's Appeal, and in support thereof represents as follows:

1. On June 8, 2017, Defendant-Appellant Scott Lively ("Lively") filed a Notice of Appeal of the district court's final order granting his motion for summary judgment. Abbreviated Electronic Record ("AER") at 151.
